RECOMMENDED CARE FOR SUNTEK PAINT PROTECTION FILM ULTRA

For maximum performance of this product, it is recommended that care consistent with the vehicle manufacturer's specifications for the exterior surfaces be followed. In addition:

- J. To extend the life and looks of your SunTek PPF and to maintain your warranty coverage, do not wash or wax your vehicle for a minimum of three days following Product installation. If average daily temperature falls below 55 °F, do not wash or wax your vehicle for a minimum of 7 days following Product installation.
- 2. Following this curing period, frequent washing and waxing is recommended. Hand wash with soap and water. Wax once or twice a year with a non-abrasive wax for added protection to maintain gloss. To prevent lifting, avoid automatic car washes and spraying the film edges with a high pressure nozzle hose, high powered pressure steam or a power washer.





Limited ten-year warranty coverage

Except as prohibited by applicable law, the manufacturer hereby disclaims liability for any incidental, special, consequential or punitive damages arising from any cause whatsoever, except as expressly provided herein. The manufacturer hereby excludes and disclaims any and all express warranties and, except during the applicable warranty period set forth above, also excludes and disclaims any and all implied warranties, including the implied warranties of merchantability and fitness for a particular purpose.

The manufacturer warrants professionally sold and applied SunTek® Paint Protection Film Ultra (PPF Ultra-Clear, PPF Ultra-Matte as applicable) (the "Product") against cracking, bubbling or yellowing caused solely by defects in manufacture or materials, for a period of ten years from the date of purchase of the Product. This warranty is valid only if the Product application was performed by an authorized SunTek installer in the United States or Canada in accordance with manufacturer's application procedures and applicable law.

This limited ten-year warranty applies only to SunTek Paint Protection Film Ultra. SunTek Paint Protection Film Ultra is intended for use only on fully cured OEM (original equipment manufacturer) vehicle painted surfaces. Vehicle surface repainting is not covered under this warranty irrespective of the reason for removal. The warranty coverage does not cover any defects other than those specified and is made solely to the original purchaser and may not be transferred. Dealers are not authorized to modify or extend said limited warranty in any manner. This Product is to be used only in compliance with all applicable laws. Warranty coverage is invalid if the Product is subjected to abuse, improper care or use of abrasive or unapproved cleaning agents. The manufacturer assumes no liability for damage to film or vehicle resulting from improper care. THE MANUFACTURER ALSO DISCLAIMS ANY DAMAGES OR STAINS CAUSED BY OUTSIDE FORCES OTHER THAN PRODUCT DEFECT OR ABNORMALITIES.

If any Product specified herein fails to conform to the limited warranty during the warranty period, the purchaser may obtain replacement Product, as well as removal of non-conforming Product and installation of replacement Product, at no charge to the purchaser, at any authorized SunTek Paint Protection Film Ultra installer anywhere in the United States or Canada, per the warranty coverage stated herein. The obligations of the manufacturer under this warranty are limited to the remedies set forth herein. Proof of purchase and completed warranty registration card will be required by the authorized installer to substantiate any warranty claim.
